The Bonhôte family acquired the bank in the 19th century. They were the initiators of our corporate culture, which places great emphasis on the personal relationships and mutual trust that the bank establishes with each of our clients.

In 1992, Jean Berthoud and a group of partners bought out the bank returning it to private hands. Jean Berthoud, whose own banking heritage dates back to 1785, was CEO of the Bank before his appointment as Chairman of the Board in 2010.


In 2014, Yves de Montmollin took over the management of the bank. He chairs the Group's Executive Board comprising Olivier Vollenweider, Jean-Paul Jeckelmann and Julien Stähli.

We are a founding member of Swiss Sustainable Finance, which aims to foster the integration of sustainability and ethical principles in asset management, and to promote Switzerland as the global centre for sustainable financial services.

As a member of the SIX Swiss Exchange we work with leading brokers to offer you access to most of the world's financial markets.

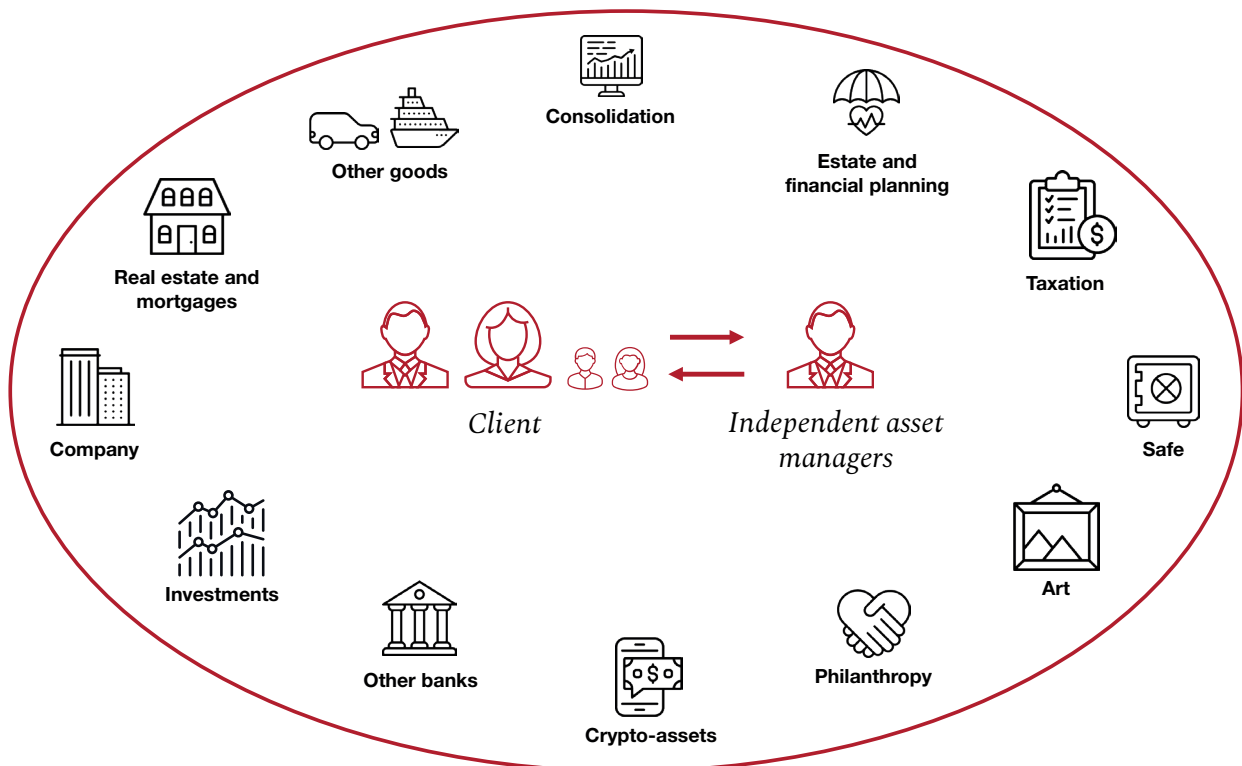
